



Script: Near Sighted Client - Rehabilitation

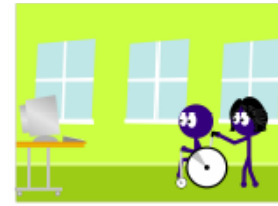


Employees becoming sick or injured at work are often left to fend for themselves. Even whilst recovering, they have to organise medical treatment and explore their entitlement to compensation. At the same time, they're coping with the effects of their injury and the financial worries that come from being absent from work.

Of 30,000 cases analysed, effective rehabilitation has reduced liability claims by as much as 20%. It will also help contain increased costs of new NHS charges.
