



Income Annuity Sales Contest and Sales Tip: "Give Your Retired Clients A Raise"

Effective Monday, Oct. 27 thru the end of 2008, the first three Platinum Income Annuity contracts you submit will earn you contest compensation in addition to your normal street comp, as follows.

- First contract \$100
 - Second contract: \$150
 - Third contract: \$250
1. When you submit each qualifying application, be sure to fax in the **Contest Submission Form**, complete with all information requested. This information will be used to process and mail each agent's contest compensation.

2. Only Agent of Record is eligible.
3. Debit cards equal to the amount earned will be mailed starting in Jan. 2009 (and monthly thereafter as contracts are issued) to address indicated on the Contest Submission Form.
4. Must be properly appointed with American General Life Insurance Company (AGL) or The United States Life Insurance Company in the City of New York (USL) to earn contest compensation and must remain in good standing with the company until the later of Jan. 31, 2009 or the date the eligible contract is issued to be awarded. Final determination of award is at the discretion of AGL or USL.
5. AGL and USL reserve the right to change this program at any time.
6. All taxes are the responsibility of the agent. In accordance with Internal Revenue Code (as well as applicable state tax law), the contest award will be reported as income to the agent.
